3. Have your body temperature to be taken before entering meeting venue. Those with high body temperature will not be allowed to enter the venue;
4. You must wear a face mask when you enter the meeting venue;
5. make use of the hand sanitizers when you enter the meeting venue;
6. keep appropriate physical distancing with each other.
